



## Terms and Conditions for the Mercedes-Benz Corporate Programme

### 1. HOW TO ACCESS PROGRAMME BENEFITS:

To access the Programme benefits, Eligible Company employees must:

- (a) purchase a new Mercedes-Benz passenger car from an authorised participating Mercedes-Benz dealer; or
- (b) purchase a dealership sales demonstrator Mercedes-Benz passenger car no older than 4 months from first registration and with no more than 4,000km on the odometer at the time of purchase;

provided that the Eligible Company employee:

- (i) registers the vehicle in the name of the approved employee or the Eligible Company; and
- (ii) provides confirmation of employment on company letterhead signed by a duly authorised representative or provides a current business card confirming employment prior to the delivery of the vehicle.

### 2. VALIDITY OF PROGRAM BENEFITS:

Programme benefits are:

- (a) Valid for up to 4 years from the vehicles first registration date.

### 3. PROGRAM BENEFITS:

The Programme Benefits are as follows:

- (a) Reduced dealer delivery fee if the vehicle you purchase is an eligible vehicle;
- (b) Free carpet floor mats if the vehicle you purchase does not come standard with carpet floor mats;
- (c) Complimentary scheduled servicing for up to 4 years from the vehicle's first registration date, being 1 year complimentary in addition with the 3 years scheduled servicing which is provided on all new Mercedes-Benz passenger car vehicle purchases. Complimentary scheduled servicing must be conducted at an authorised participating Mercedes-Benz dealer. Only items covered by the Scheduled Service Plan are covered. All other items are excluded and at your cost.
- (d) 4 Year Owner Protection Plan, being 1 year complimentary in addition with the 3 Year Owner Protection plan which is provided on all new Mercedes-Benz passenger vehicle purchases.
- (e) During the period of complimentary scheduled servicing (detailed in paragraph 3(c) above) complimentary pick up and drop off of your vehicle may be provided up to 25 kilometres in each direction of the participating servicing Mercedes-Benz dealership subject to availability. Alternatively, a loan vehicle (the model type to be provided at the authorised participating Mercedes-Benz dealer's discretion) will be provided at no charge subject to availability.
- (f) 4 years total Road Care Service is included with each vehicle purchased under the Programme, being 1 year complimentary in addition with the 3 years Road Care Service which is provided on all new Mercedes-Benz passenger car vehicle purchases. Refer to the Road Care Brochure terms and conditions or further information.
- (g) Competitive rates and tailored financial services solutions are made available by Mercedes-Benz Financial Services NZ Ltd ("MBFSNZ"), subject to our standard credit approval process.
- (h) Access to the Corporate Programme vehicle evaluation fleet. Where a suitable vehicle is not available at a participating authorised Mercedes-Benz dealership for the purpose of a test drive, the Mercedes-Benz dealership can contact Mercedes-Benz New Zealand Limited ("MBNZ") to request access to a vehicle which MBNZ may, at its sole discretion, provide for a test drive subject to availability.

### 4. OTHER:

(a) In addition to the Programme terms and conditions, the Mercedes-Benz dealership's terms and conditions apply to your vehicle purchase. (b) MBNZ at its absolute discretion may terminate the Programme at any time, for any reason and without notice. Existing members will continue to receive the Benefits under this Programme until those Benefits expire. (c) Mercedes-Benz Corporate Programme is available for Authorised Mercedes-Benz Passenger cars only.

### 5. PRIVACY:

You agree that this form and the details of your proof of employment and a copy of your sale and purchase documentation may be retained by the Mercedes-Benz dealership and shared with MBNZ (a member of the Daimler group) for audit purposes in relation to this Programme.
